PURPOSE

We are partnership-centered, committed to collaborating with a variety of state and local organizations across the state who believe local revenue modernization can positively impact a diverse set of economic, nonprofit, educational, and civic needs. Through a multi-year campaign of fundraising, research, marketing, and daily coordination of resources, we are laying the groundwork and infrastructure statewide for a November 2024 ballot referendum to amend Section 181 of the Constitution of Kentucky.

Funds Raised **\$455,000**

In 2023, we saw our Commonwealth go through macro changes – economic, political, environmental – that caught headlines and spurred excited discussion of our future. Meanwhile, we watched our communities continue to suffer from the micro-level problems that only seem to worsen stemming from lack of local decision-making and economic competitiveness. Many cities and counties experienced growth only due to federal pandemic relief dollars that will expire at the end of 2024; local tax rates were raised and lowered trying to find the 'sweet spot' of meeting a fiscal bottom line without overburdening residents during already-difficult economic times; and local officials wondered what the impacts of a lowering state income tax rate would have on their resources.

We know that ballot referendums and constitutional amendments are difficult - that is not unique to Kentucky. But YDK! is. YDK!'s core purpose is to lay the groundwork of educational and organizational resources to ensure that Kentuckians know why this referendum and amendment are important.

We see our uphill battle every day, and we also know that our actions are making a difference, reflected in the momentum apparent in the determination to 'solve this puzzle' by state officials, the continued prioritization of local tax reform by local leaders, and the expansion of our grassroots coalition at every corner of the state. All of these factors aid us to refine and strengthen each day, always in our nimble and responsive style, bulldozing towards November 2024.

Together with local partners, we provided education to regional leaders to expand and strengthen the reach of our coalition.
